The new millennium witnessed phenomenal nationwide growth in local, independent education foundations. Shortly thereafter, several York County school districts established education foundations. In turn, a York Suburban community steering committee began meeting in 2007 to determine the feasibility of a similar endeavor for our community. The diligence and vision of this group set the framework and mission that enabled the school board to unanimously adopt a resolution of support in March of 2008. As a result, the official organization of the York Suburban Education Foundation (YSEF) was formed.

Dedication and passion are vital to the success of any volunteer organization, but meteoric is an accurate description of our inaugural efforts as we exceeded board projections. To date, very successful fundraising campaigns and a "Celebration of Excellence" Gala were held raising a combined total of \$98,485. 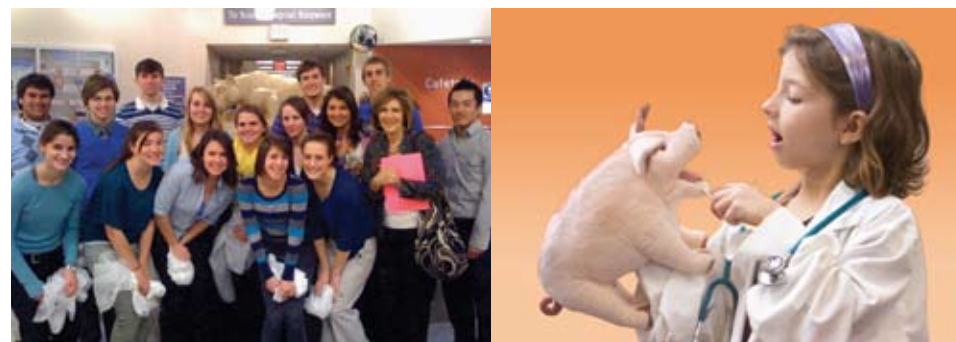

EITC Tax Credit

The York Suburban Education Foundation (YSEF) has been approved by the state's Department of Community and Economic Development as an Act 48 organization. This means businesses that fall within the Educational Tax Credit Improvement Program (EITC) tax guidelines may apply for tax credits when they make contributions to educational improvement organizations like YSEF.

Businesses subject to the following taxes may apply to the Department of Community and Economic Development (DCED) for tax credit:

Corporate net income tax, capitol stock franchise tax, title insurance company shares tax, insurance premiums tax, bank and trust company shares tax, mutual thrift institutions tax, personal income tax of "S" corporation shareholders or partners in a general or limited partnership.

Eligible businesses that submit an application to the DCED and agree to make a contribution to an educational organization shall be awarded tax credits up to \$300,000 per taxable year. If a business agrees to contribute to the same organization for two consecutive years, its tax credit may be increased to 90% of the contributions made that year.

For an EITC application, go to www.newPA.com/EITC. The PDF format is recommended when printing the form from the website. All potential donors should consult with their tax preparers before submitting a finalized application.

YSEF GRANT PROGRAM

The YSEF grant program provides grants to teachers, students, administrators and the York Suburban community in furtherance of the Education Foundation's mission.

Types of grants include:

- **Professional** (available to teachers and administrators)
- **Classroom** (available to teachers, students and administrators)
- **Special Projects** (available to members of the YS community, teachers, students and administrators)

To date, the Foundation has awarded nearly \$25,000 in grants for programs that are enriching the lives of students, teachers, administrators, and the surrounding community.
