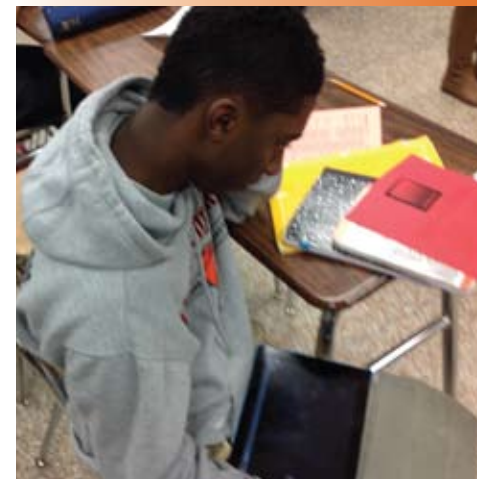

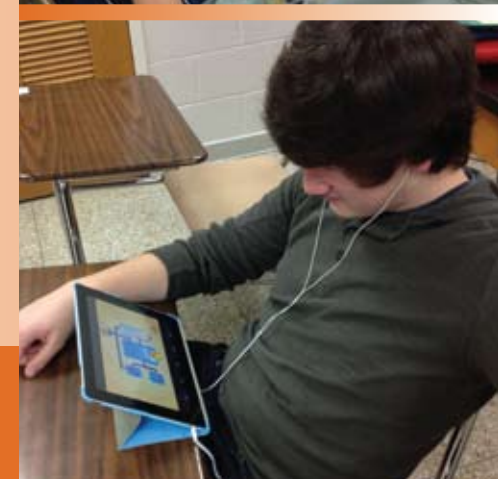
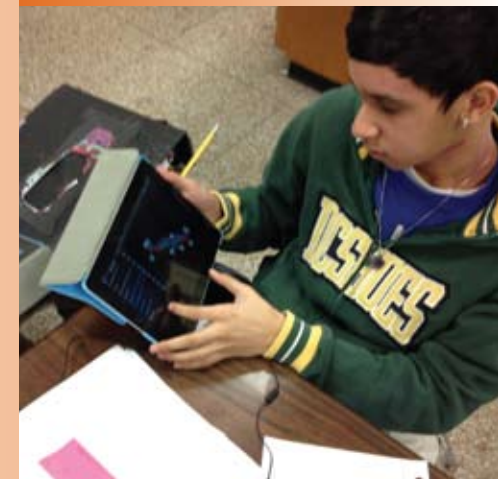

Led by the outstanding efforts of Chair, Crystal Miller, and Co-Chair, Sarah Perkins, the event raised \$33,000.
